Client Agreement

I. Fees

- a. I have reviewed the Rates Schedule and Package Prices for my upcoming ceremony and/or educational services (i.e. tutoring sessions) and/or consultation meetings and agree to pay in full. I am aware that I can request a special payment arrangement in writing. I agree that verbal arrangements are invalid.
- b. I agree to pay for my ceremony and/or educational service and/or meetings in full no later than four (4) weeks before my ceremony date and/or the date of my first tutoring session or meeting. I will pay immediately when the ceremony and/or the commencement of educational service and/or meetings is less than four (4) weeks away.
- c. I agree that late payments will be assessed a \$50 handling fee unless agreed otherwise in writing.
- d. I agree that simple.meaningful Ceremonies, aka Rabbi Reuben Modek, may withhold officiating at my ceremony, and/or cease to provide educational services and/or cancel scheduled meetings, when my balance remains outstanding as per the due date stated in this agreement, or as per the due date written in a special payment arrangement.
- e. I agree that simple.meaningful Ceremonies will not reimburse tuition for missed sessions (i.e., weekly tutoring sessions), and/or missed meetings (i.e., marital empowerment) due to absence or departure caused by the client's (parent, child, family, couple) choice and/or circumstance (i.e., sports, illness, work etc.).
- f. I understand that my deposit payment(s) secures the ceremony date and times and/or the dates and times for tutoring sessions and/or meetings on the rabbi's/tutor's calendar, and that deposits are non-refundable.

2. Cancelation and rescheduling

- a. I agree that simple.meaningful Ceremonies will deliver my ceremony only on the date and times that I provided on the simple.meaningful Ceremonies electronic registration form.
- b. I agree that the dates and times of tutoring sessions and/or meetings (the schedule) that I approved in writing at or close to registration are alone the dates and times our rabbi/tutor is committed to.

- c. I acknowledge that the approved schedule is kept on record in <u>Name's</u> (parent, child, family, couple) Ceremony Notebook, and that I requested and received from the rabbi/tutor an electronic link to the shared document titled "<u>Name's</u> Ceremony Notebook" on Google Drive.
- d. I understand that simple.meaningful Ceremonies is committed to provide me, the client (parent, child, family, couple) with tutoring sessions and/or meetings only on the dates and times of the approved schedule.
- e. I agree that the rabbi/tutor will not make up missed sessions due to client absence for any reason (i.e. sports, illness, work, etc).
- f. I understand that when I request to reschedule a tutoring session and/or meeting one week (7 days) or more in advance the rabbi/tutor will make a good faith effort to accommodate my request but is not obligated to do so. The rabbi/tutor may choose to provide written makeup information/ homework instead.
- g. I understand that if Rabbi Modek is unable to perform my ceremony during the agreed upon time, simple.meaningful Ceremonies may:
 - 1. reschedule the ceremony if reasonably possible; 2. refer a qualified clergy person as a substitute; 3. reimburse ceremony fee(s).
- a. I understand that if the rabbi/tutor is unable to meet with me and/or tutor me, simple.meaningful Ceremonies may choose to:
 - 1. reschedule the meeting/tutoring session; 2. refer a qualified substitute; 3. reimburse the session's prorated value.

3. Photo/Videography

I agree that simple.meaningful Ceremonies may use any photographs/ videos taken by simple.meaningful Ceremonies representatives during a ceremony or tutoring sessions, or photos/videos taken by, and shared by me, for promotional purposes including social media marketing. I understand that I may opt out of promotional photos/videos by submitting a written request (text, email, snail mail) to the simple.meaningful Ceremonies office.

I agree that none of the above Client Agreement clauses may be changed orally.
